In its 16 years, Conservation Foundation of the Gulf Coast has protected 42 properties representing 11,998 acres, creating preserves and conservation areas across five counties. The Foundation collaborated with 55 private, public, and not-for-profit organizations in the past year. The Foundation's mission is supported by over 1,000 donors annually. Cumulatively over the past 16 years, total revenues exceeded \$50,500,000 derived from contributions, grants, and other program fees such as contract work with Sarasota County's environmentally sensitive land acquisitions program.

Both properties are in the Myakka River region and will contribute to water quality, flood prevention, and habitat protection.
